The jury of experts, usually consisting of five members, approves proposals for awards for exceptional work of Slovak artists (from all areas of art), scientists (from creative, humane and public areas) and sometimes also foreign artists an scientists (in regard to spreading their ideas of identity, peace continuity and development of arts in the world).

Article II.

Mission of the project

- 1. Identification Code of Slovakia is a part of Culture code of the world.
- 2. It is supported by the European academy of sciences and arts in Salzburg.
- 3. This cultural project will represent work of know and less-known, or today almost forgotten artists. Work of renowned artists with emphasis on their message about era they lived in and created information hidden in values for the future generations. Each of these artists represents quality in our and foreign culture. None of them should be forgotten. Without them, our culture as well as our civilization would not be developed as we know it today. Our presence would be different.
- 4. Mission of this project is also to highlight uniqueness of the original home and foreign work in the united Europe. To systematically draw attention on continuity of artistic development. To remind the public that culture is formed by one large base with various levels of artistic value.
- 5. Culture and identity create a stability of the word peace also today.
